2021-2022 Contract, Fees and Expectations

Welcome to the Musical Theatre family! Being a part of the cast is a four month commitment. ***Please read this contract thoroughly and return to the studio by January 10, 2022 to claim your spot. Cast members without a signed and returned contract by January 10th may lose their position in the cast.***

Tuition - \$70/month

Due on the 1st of each month and will be automatically charged to the credit/debit card on file. **Every studio account is required to have a credit or debit card on file**, but there is still an option to pay in cash/check if you prefer that method. If tuition is not received by the 5th, a \$15 late fee is automatically applied. There is a 10% sibling discount available.

Costumes/Performance Attire

Most costumes will be your responsibility. There are some costumes which might require a rental fee. More information will come. It is possible your child could have 3-4 costumes in the show. We try to keep them as cheap as possible. Deseret Industries, Goodwill, and other thrift stores are a great place to find costumes and accessories. **If costumes are not returned by the cast party, you will be charged a late fee for them.**

Scenery and Prop Fee

We highly encourage each family to donate 10 hours helping with scenery, props, or costumes. If you can't donate your time, you will be charged a scenery and prop fee of \$35 for the first child, and \$20 for additional children.

Main Cast Rehearsals

We have scheduled three main cast rehearsals. If your child is chosen as a lead, he/she must attend all rehearsals. You can miss no more than one.

Performances

Students in Musical Theatre Junior are required to attend all scheduled rehearsals and performances. All performances are required events and can only be excused by Shannon 1-week prior to the performance date.

Reasons for Disciplinary Actions

Attitude issues, payment issues, or dependability issues that do not change will result in dismissal from class, suspension from the program, or dismissal from Musical Theatre Junior. with no refunds. ***Should you choose to end your contract before the run of the show is up, without Director approval, your account will be charged an automatic drop fee of \$150.***

Dress Code

Wear modest attire (no cleavage, no tummies, no booties hanging out, no midriffs showing when you raise your arms).

Communication

We use **TeamApp** as the main form of communication. It is **required** that all Musical Theatre parents and performers download the app and **keep notifications on**. This will ensure that you are always up to date with the calendar. Chats within TeamApp are useful as well to coordinate rides and ask questions.

Absences/Tardies

All absence requests need to be submitted and approved by Shannon. Absences need to be submitted at least 24 hrs in advance unless due to illness. Unexcused absences are never acceptable. Even if absences are excused, you may still be removed from a number if they affect the student's ability to learn the number and/or negatively affects the group by not being there.

If a student is tardy for any class at any time they need to enter the room quietly and join in. We are trying to encourage promptness in arrival. Please ensure you get your child to rehearsals on time.

Rehearsal Videos

All rehearsal tracks and videos can be accessed in Team App. It is the student’s personal responsibility to view videos and performance tracks to rehearse.
